

KRSP Terms & Conditions

1. Who is the data controller for KRSP Inclusive Summer Camps (“Camps”)

The data controller is KRSP, John’s Green House, John’s Green, Kilkenny.

2. Who is the Data Protection Officer of KRSP?

3. With whom will we share your data?

3.1. We may share your data with the following Camp personnel:

3.1.1 Camp Co-ordinator

3.1.2 Camp Leader

3.1.2 KRSP Staff

4. For what purposes will my child’s personal data be used and on what basis?

4.1. Your child’s personal data requested will be used for the purpose of administering the Camp and performing the contract with you. If you fail to provide the information requested, your child will not be accepted to participate on the Camps.

4.2. If you have explicitly consented that we may do so by ticking the relevant boxes on the application form, your/your child’s personal data may also be used to:

4.2.1. administer medication to your child in the event of an emergency, convey your child to a Doctor or hospital and to share that information with medical personnel

4.2.2. contact you by e-mail or telephone for research purposes;

4.2.3. notify you of future KRSP Programmes

5. Can I withdraw my consent at any time?

You may withdraw your consent at any time to the processing at paragraph 4.2 by writing to Nicola Keeshan, KRSP Co-Ordinator, John’s Green House, John’s Green, Kilkenny. If you withdraw your consent, such withdrawal will not affect the lawfulness of the processing prior to the withdrawal of your consent.

6. How long will KRSP retain your/your child’s personal data?

6.1. Unless you have explicitly consented to us retaining your/your child’s data for the purpose of notifying you of future Camps, we will delete your/your child’s data within two months of the conclusion of the Camp for which your child was registered.

6.2. If you have consented to us retaining your/your child’s data for the purpose of notifying you of future Camps, we will retain your/your child’s data for a period of two years, unless you withdraw your consent earlier.

7. Right to request access to, rectification, erasure of personal data or restriction of processing or data portability

7.1. You have the right to access any personal data which we hold about you/your child or to request the rectification of any information that we have about you. If you would like to access or rectify your personal data, please send your request in writing to Nicola Keeshan, KRSP Co-Ordinator, John’s Green House, John’s Green, Kilkenny.

7.2. In certain circumstances, you have the right to request that we erase your/your child’s personal data, the right to restrict our use of your/your child’s data and the right to data portability. For further information, please write to Nicola Keeshan, KRSP Co-Ordinator, John’s Green House, John’s Green, Kilkenny

8. How do I make a complaint or report a breach?
