<b>Aim of Scheme</b>	To support clubs and organisations to continue to rebuild and re-engage participants post the impact of COVID-19 on their organisations focusing on programmes to increase participation or support volunteer recruitment /engagement/training
<b>Max Grant Amount</b>	€1,500
<b>Who can apply?</b>	<ul style="list-style-type: none"> <li>Sports Clubs &amp; Community Groups/Organisations where physical activity and sport is the main activity.</li> <li>Community Sports Facilities.</li> </ul>

## 3 Women in Sport Support Programme

**Aim of Scheme**  
KRSP are supporting local clubs, groups and community organisations that promote increased participation in recreational sport or physical activity for women and girls in Kilkenny. KRSP are encouraging clubs/organisations/groups that have the potential to increase levels and frequency of participation in recreational sport and physical activity among women and girls in the local area to apply.

**Max Grant Amount** €750

**Who can apply?**

- Sports clubs
- Community Groups and Organisations

**Who CANNOT apply?**

- Sports Clubs/Group/Organisations who did not attend the KRSP Grants Scheme workshop.
- Individuals, For-profit groups, Commercial organisations.
- Private facility owners, National/Regional/ County Bodies/Statutory agencies.
- Sports clubs/community groups that have not fully engaged and/or drawdown previous grant funding.

### What Costs are Eligible? \*

Sport / Physical activity programmes for women/girls

Communication and marketing for female only programmes/events

Tutor costs for all-female programmes.

Equipment costs for all-female programmes.

1. Attend KRSP online information workshop on KRSP Grants Scheme 2024	10 <sup>th</sup> July @ 7pm
2. Clubs/organisations can apply online using MS Forms. <a href="https://forms.office.com/r/k3iFS6zmnz">https://forms.office.com/r/k3iFS6zmnz</a> . Deadline for submission of grants	31 <sup>st</sup> July 2024
3. Assessment of grant applications.	1 <sup>st</sup> August 2024 - 31 <sup>st</sup> August 2024
4. Clubs will be notified by email if successful/ unsuccessful.	By 6 <sup>th</sup> September 2024
5. Clubs must return documents and a signed funding agreement form if successful.	13 <sup>th</sup> September 2024
6. 100% funding will be transferred to club/organisation's bank account pending receipt of documents and agreement forms.	By 27 <sup>th</sup> September 2024
7. Expenditure report, all relevant and original receipts/invoices clearly marked 'KRSP Support 2024' with a ballpoint pen, programme report and confirmation of training/education completion submitted as applicable to each support scheme (notified prior to signing agreement form).	By 29 <sup>th</sup> November 2024
8. <b>Close off support schemes</b> - Sports clubs that do not comply with submitting receipts/invoices and reports will be required to repay all funds to KRSP.	By 13 <sup>th</sup> December 2024
<b>Please Note</b> Applications from sports clubs and organisations that have not fully engaged with the drawdown process of previous grant funding will not be considered.	

## Application Contact Person

Each sports club/community group/organisation must provide contact details for the person making the application on behalf of the club. KRSP will only deal with the applicant in administering the support scheme. Any changes to the contact person must be notified to KRSP in writing immediately with contact details for the new contact person. The contact person must make themselves aware of deadline dates.

1. Signed Agreement Form

4. Child Safeguarding Statement
5. Constitution, Memorandum & Articles of Association or another Governing document
6. Insurance Company name and Policy Number
